## **Annuities & Trusts**

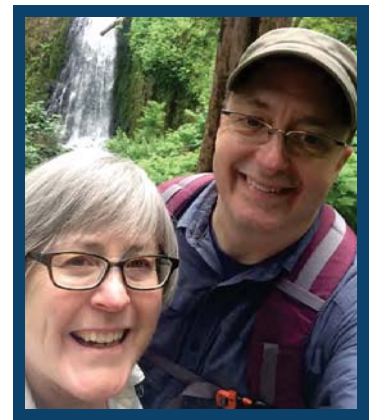
